As per provision in Budget Manual Rule 12.9 read with Appendix G & H, BM 26 and BM-29 is an important budgetary statement prepared by DDO and submitted to Head of Department each mogth. It keeps record of appropriation and expenditure under a major /minor and sub-head Concerned. The Disbursing Officer keeps its control over the expenditure through these statements.

With the passage of time, under Mission Mode Project Treasury Computerization Scheme under National e-governance action plan, the State Govt. has fully implemented the Treasury Computerization which is running successfully throughout the State. Finance Dash Board has been developed which is available on Treasuries & Accounts web portal i.e www.hrtreasuries.gov.in in under Budget Allocation. In this dash board, the expenditure is monitored online throughout the State. The expenditure incurred against each Object Head wise against budget provision is available on day to day basis for all the schemes of each department including Plan & Non Plan schemes for the concerned financial year and Head of Department/DDO can view and download the Expenditure of all Schemes.

Hence the necessity of preparing and submitting BM 26 & 29 is of no use and needs 3. to be dispensed with immediate effect.
