Subject: Revision of pension and other issues pertaining to pensioners/family pensioners.

Sir/Madam,

I am directed to invite your attention to this department's memo No. 2/51/2008/-1 Pension, dated 04.11.2015 vide which all pre 1.1.2006 pensioners/family pensioners were directed to make request to the department concerned (for stepping up pension/family pension) instead of forwarding their applications directly to the Finance Department.

2. It has been observed by the Finance Department that pensioners/family pensioners of State of Haryana are sending/forwarding their representations on various issues directly to the Finance Department instead of addressing the same to their departments concerned for solving their problem/grievance. It is worthwhile to mention here that the complete data (service record) of the pensioners/family pensioners are with the departments concerned. Hence, they are in a better position to solve the grievances of the pensioners/family pensioners at their level.

3. Secondly, Finance Department issued various notifications/instructions time to time for the welfare of pensioners/family pensioners of the State of Haryana. However, these instructions are being implemented by the departments concerned at their level.

4. Each and every case of the pensioners/family pensioners should be examined by the department on merit and if necessary they can seek clarification on different issues from the Finance Department by sending detailed proposal.

5. It is, therefore, requested that pensioner/family pensioner of the department concerned may be directed to first approach the department concerned instead of forwarding their representations directly to the Finance Department.
