Subject:- Installation of Point of Sale (POS) Machines in Government to Cashless Transactions in the State.

Kindly refer to the subject noted above.

2. Consequent upon the decision of the Government of India to withdraw Specified Bank Notes of Rs. 500/- and 1000/-denomination, the Government of Haryana has decided to promote cashless transactions through electronic mediums like debit/credit cards especially the Rupay card and through other mode of digital payments to enable ease of doing business in the State.
3. The State Bank of India (SBI) has agreed to provide the POS machine facility free of charge to the State Government/its Departments across the State. The SBI will not charge any fee either from Government / Departments or from the customers. The transactions settled through POS terminals will be credited by SBI to the respective Department's Drawing and Disbursing Officers (DDOs) bank accounts on T+1 basis (T denotes transaction day).
4. The concerned DDO will deposit the amount received from SBI through POS Machines immediately in the State Treasuries through e-gras (Government Receipts Accounts System) using net banking or by off line mode as presently in practice.
5. In order to facilitate the seamless operation of POS Machines, Departments are allowed to open one centralized bank account at DDOs level with SBI, exclusively earmarked for transactions done on POS Machines by relaxing the FD's instructions No. 28/21/2012-SB&C dated 11.02.2016 regarding closing of bank accounts as a special dispensation.
6. You are, therefore, requested to identify the location for installation of POS Machines in consultation with SBI and provide requisite infrastructure facilities like landline with net connectivity, mobile connectivity etc, for it. List of contact persons of SBI is enclosed. Similarly, Departments will provide the details of Nodal Officers to SBI, who will coordinate with Department's field Offices as well as SBI and organize training workshops etc.
7. The Departments are required to enter into separate agreements with SBI for opening of bank accounts as well as for installation and maintenance of POS Machines as mentioned in clause 20 of the MoU.
8. These instructions alongwith MoU are also available on the website of Finance Department i.e. www.finhry.gov.in.
