No. Elec-2017/IR-II/PSCE/Hol/ 18293 Whereas bye election on the vacant seats of Panches, Sarpanches of Gram Panchayats and Member Panchayat Samities and the General Elections of three Gram Panchayats i.e Gram Panchayat Chandu and Wazirpur, Block Gurugram and Gram Panchayat Budhera, Block Farukh Nagar, District Gurugram for which poll shall be held on 29.06.2017 (Thursday) as per notifications of the State Election Commission, Haryana issued vide notification No. SEC/4E-II/2017/1586 dated 05.06.2017.

And whereas, it is considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes "Thursday" the 29.06.2017 to be close day (holiday) for all shops and commercial establishments falling in the above mentioned jurisdiction of all Gram Panchayats. Panchayat Samities where bye election are to be held as per annexure A of the said notification and three Gram Panchayats i.e Gram Panchayat Chandu and Wazirpur, Block Gurugram and Gram Panchayat Budhera, Block Farukh Nagar, District Gurugram, respectively in the State of Haryana where the General Election is going to be held on 29.06.2017 (Thursday) as per notification of State Election Commission as mentioned above.
