No.: -11/55/2017-4Lab., The schedule appended to the Rule 8 of the Punjab Factory Rules, 1952 framed under the Factories Act, 1948 specifying the factory license fee for grant of factory license was amended inter alias vide notification No. 11/16/2016 – 4 Lab dated 17th February 2017. The issues have been raised by the factory owners / occupiers regarding the applicability date of this revised factory license fee.

After due consideration, it is hereby ordered that the revised factory license fee as notified vide dated 17th February 2017 shall be applicable prospectively only on the factory license applications for fresh or renewal or amendment applications received on the Labour Department, Haryana e-service hosted on website www.hrylabour.gov.in on or after 17th February 2017. It is clarified that factory license fee as it exists before the said notification shall be levied on the online applications for factory license received on www.hrylabour.gov.in on or before 16th February 2017.

It is further ordered that no revised fee shall be levied on the online applications received on or before 16th February 2017 even for multiple years including or crossing the year 2017 i.e. part period falls before and after the 17th February 2017.

However, in case of receiving the amendment applications of such factory license application on or after the 17th February 2017, the revised factory fee shall be levied only for the subsequent years of the original applications e.g. if an original application has been made for years 2015 to 2019 on dated say 10th November 2014, in case of its amendment application received on or after 17th February 2017 say on dated 25th August 2017, the revised factory fee shall be levied only on the remaining part of the license period i.e. for the years 2017, 2018 & 2019 and not for the years 2015 and 2016 or as the case may be.
