No. Elec-2018/IR-II/PSCE/Hol/ 5546 Whereas the Bye-Election to one Lok Sabha and two Assembly Constituencies of Rajasthan-2017-18 i.e. 8-Alwar Parliamentary Constituency and 13-Ajmer, 183- Mandalgarh (Bhilwara) Assembly Constituencies for which poll shall be held on 29.01.2018 (Monday) as per letter issued by the Chief Electoral Officer, Haryana, vide letter No. 130(Pub.Holiday)/Elec-2014-18/2AE-177 dated 10.01.2018.

And whereas, it has been considered necessary to provide opportunity to those who are working in the State of Haryana and enrolled as voter in 8-Alwar Parliamentary Constituency and 13-Ajmer, 183- Mandalgarh (Bhilwara) Assembly Constituencies in State of Rajasthan to exercise their franchise.

Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fix "Monday" the 29.01.2018 to be a close day (holiday) for all Shops and Commercial Establishments falling within the jurisdiction/area of the State of Haryana only for these employees who are enrolled as voters in the above mentioned constituencies to enable them to exercise their franchise.
