The SETC Test consists of two parts i.e. Part-I Basic Computer Knowledge test, where the passing percentage is 50% & Part-II typing speed of 30 words per minutes in English and 25 words per minutes in Hindi converted with equivalent key depressions in both cases as the typing speed would be tested on computer (the candidate can appear either in English or in Hindi or Both). As per the letter dated 07.11.2013 and dated 22.09.2017 the State Government had exempted some diplomas/courses/degrees from appearing/passing the 1% component i.e. Basic Computer Knowledge Test. However, the typing speed test is mandatory for all the candidates/employees even if they are exempted from 1st component. Hartron has been authorized by the State Government for conduct of SETC Test.
