No. Elec-2018/FW/PSCE/Hol/ 1724 Whereas the Bye Election- to 02-Kailana Parliamentary Constituency of Uttar Pradesh-2018 for which poll shall be held on the 28.05.2018 (Monday) as per notification of the Election Commission of India, issued vide notification No. 130 Elec-2014-18/2AE-2017 dated 25.05.2018

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt only those workers who are working in the factories of the State of Haryana and are enrolled as the voters in 02-Kailana Parliamentary Constituency in the State of Uttar Pradesh, where Bye Election are to be held on 28.05.2018 (Monday) from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 27.05.2018 and ending on 02.06.2018, subject to the condition that no adult worker who is enrolled as voter in 02-Kailana Parliamentary Constituency of Uttar Pradesh-2018 shall be required or allowed to work on 28.5.2018 (Monday) in the factories of the state of Haryana.


