**OFFICE ORDER**

Consequent upon registration of FIR No. 34 dated 06.12.2014 under section 7, 13 of P.C Act, PS SVB Rohtak, Sh. Jaipal, Reader O/o Assistant Director, Industrial Safety and Health, Circle-II, Faridabad was placed under suspension w.e.f. 06.12.2014 vide office dated 10.12.2014 issued Endst. No. 48003-08 dated 15.12.2014.

Now, the special court of learned Session Judge, Jhajjar vide its judgement and order dated 27.08.2018 has acquitted Sh. Jaipal from the charges levelled against him.

And, as per information received from Superintendent of Police, State Vigilance Bureau (H), Rohtak Range, Rohtak vide latter No. 3109 dated 12.10.2018 that the District Attorney, Jhajjar and Deputy District Attorney, Superintendent of Police, State Vigilance Bureau (H), Rohtak Range, Rohtak have opined that the case is not fit for filing an appeal against the acquittal of accused Jaipal.

In view of the above, Sh. Jaipal, Reader is hereby reinstated with immediate effect and posted at Hqrs. His reinstatement will be subject to filling of appeal, if any by the State of Haryana against the acquittal order. The suspension period from 06.12.2014 to till date of Sh. Jaipal, Reader will be treated as duty period for all purposes and all service benefits (include arrear of salary) for the aforesaid period will be restored to him accordingly.
