Sub: General Election to Haryana Vidhan Sabha, 2019- protocol with regard to personnel who sustain injury/fall sick or die-treatment of security & polling personnel during election duty-Regarding.

## Sir/Madam

2 I have been directed to invite your attention to the subject mentioned above and to state that the Haryana Government has decided to provide medical treatment on cashless basis to personnel who sustain injury/[all sick or die during General Election to Haryana Vidhan Sabha, 2019.

3. For Haryana Vidhan Sabha General Elections -2019, the instructions are as under:

A. For Haryana Government regular employees deployed on election duty (security/polling personnel), the instructions vide no. 2PM-Cashless-2017/13626-13786 dated 20.11.17 and amendment vide no. 2PM-Cashless 2018/2158 2318 dated 04.04.18 shall be applicable.
B. However, the instructions for all other Non-Harvana Gaussian

However, the instructions for all other Non-Haryana Government regular/contractual employees deployed as security/polling personnel are as under:-

- a. This provision shall be applicable during the Haryana Vidhan Sabha General Elections -2019 only
- b. It will be the responsibility of the concerned District Election Office to provide the list of polling/security personnel during the Haryana Vidhan Sabha General Elections 2019 as is the category of poll personnel.
- c. It will be responsibility of concerned District Election Office, to issue valid ID to polling /security personnel deputed during the Haryana Vidhan Sabha General Elections -2019.
- It shall be responsibility of security/polling personnel to produce the valid ID to the Hospital.
- e. It shall be responsibility of the Presiding Officer of the concerned centre to certify that the injury sustained has been due to violent attack or of fall sick, while being deployed for election duty. The medical bill of such polling /security personnel will later be counter signed by appropriate authority. O/o concerned District Election Office.
- f. It will be responsibility of the Civil Surgeon of the concerned district to ensure that best of the medical treatment on cashless basis is being provided to the personnel deployed for election duty in the Haryana State.
- g. For smooth coordination, Dr. J.S. Grewal, ADGHS (contact no. 7027326333) is hereby designated as State Nodal Officer, Health Department, Haryana
- It will be responsibility of the Civil Surgeon of the concerned district to share name and contact number of nodal officer of their district to District Election Office and also to DGHS Haryana.

- i. All such Medical Bills to be sent to O/o DGHS, Haryana (through proper channel) for working out of bills.
- The Health Department Haryana will release the worked out amount to the concerned hospital.
- k. Instructions shall be applicable to all Government Medical Colleges/Government Aided Medical Colleges in Haryana, in all districts Hospitals and other Health Institutions of Haryana Government & in all private Hospitals empanelled with Haryana Government for providing immediate medical care to personnel deployed for election duty with no delay or denial in treatment on cashless basis.
- The follow-ups of such conditions after Vidhan Sabha Election-2019 shall not be entertained by the State Government. For this, the claimant has to submit his/her medical bill to his/her State or concerned department for payment.
- m. During election period, in case of any emergency, the facility of air ambulance would be available. A team of doctors and para-medical staff along with necessary medicines would be provided by the Health Department through concerned Civil Surgeon.

## C. Additional instructions for private hospitals empanelled with Haryana Govt.:-

- The private empanelled hospitals will give 100% Cashless service for the treatment given under prescribed package rates, notified by Govt. of Haryana vide dated 21.05.2015.
- For Non-Package Procedure private empanelled hospitals will give 25% discount on the final bill. However, for remaining amount, the bill of the personnel deployed for election duty will be submitted in O/o DGHS Haryana for the payment.
- iii. In case, there is no private empanelled hospital or the empanelled hospital is far from the polling centre then personnel deployed for election duty may go to the hospital empanelled under Ayushman Bharat Scheme Haryana.

In such case, the hospital will raise the bill as per the Ayushman Bharat package rates and the same will be submitted in O/o DGHS Haryana for the payment.

iv. All hospitals will furnish their bank details (Name of bank, Account number, IFSC code, MICR code, PAN number) with the medical bill to the Nodal Officer of the Health Department for transfer of payment electronically.
