Sir/Madam,

I am directed to invite your attention to this department's memo No. 2/7/2016-1 Pension dated 18.03.2016 followed by reminder of even number dated 25.05.2016 vide which it was requested to send the report to Finance Department (in Pension Branch) duly signed by BDO/SAS Personnel (Senior Most) in respect of those pensioners/family pensioners whose pension/ family pension has been fixed in modified pay scales instead of corresponding pay scales and are getting/drawing excess pension/family pension which is violation of OM dated 06.02.2015 and clarification issued vide dated 04.05.2015 and 04.11.2015. If any case has been found then the same may be revised immediately as per OM dated 06.02.2015. The action against officer/official concerned, who are responsible for such wrong revision be initiated immediately. But the above said requisite information has not been received so far (except from some offices).

2. It is, therefore, again requested to send the consolidated report/information of your department immediately **without any further delay. Any lapse in this regard will be viewed seriously.**

3. The information already supplied to the Finance Department (Pension Branch), need not to send again.

4. Further the name of the officers/ officials concerned who are responsible for delaying the information should be sent for further action.
