
Terms of Reference:

The Advisory Group will meet at periodic intervals to oversee completion of the following activities within a reasonable time-frame pertaining to roll-out of PFMS.

- i) Complete State Treasury Integration with PFMS i.e. Configuration of State Schemes on PFMS, Mapping of State Schemes with Central CASP Schemes, Configuring State Scheme components, Identifying and configuring hierarchy of each State Scheme, Integration of PFMS with scheme specific software application, if any
- ii) Registration of all State Implementing Agencies (SIA) on PFMS
- iii) Deployment of Trainers (Resource persons)
- iv) Review Training of Trainers
- v) Provide continuous support for implementation and to resolve day-to-day issues.
- vi) Provision of Office Space & Other logistic support for SPMU
- vii) Provision of Office Space, manpower & other logistic support for DPMUs
- viii) Ensure Hardware availability/ Internet Connectivity at District/Block Level
- ix) Deployment of Resource persons- Technical (NIC/Consultants)

The State Advisory Group (SAG) may invite any other officer/officers for meeting as and when required.

Planning Department will provide the secretarial support to the Advisory Group.
