I am directed to invite your attention on the subject noted above and to say that the Government of India has universalised the roll-out of Public Financial Management System (PFMS) for all Central Sector (CS) Schemes and Central Assistance to State Plan (CASP) Schemes and also intend to extend the facility to State Schemes. - iv) Identity implementation hierarchy of each scheme
- v) Integration of Systems Interface of specific schemes
- vi) Deployment of Trainers(Resource Persons)
- vii) Training of Departmental Trainers
- viii) Periodically review of progress of functioning of PFMS
- ix) Review of expenditure
- x) To Submit progress report of the implementation of PFMS to the State Advisory Group (SAG) for further actions
