
Subject :- **Regarding implementation of E-Stamping in the State.**

Please refer to FD instruction dated 27.04.2016 vide which State Government had made e-stamping mandatory in four Districts i.e. Faridabad, Gurgaon, Panchkula and Sonapat w.e.f. 02.05.2016 and FD instruction dated 02.02.2017 making e-Stamping mandatory in the remaining districts w.e.f. 01.03.2017.

2 It has been decided that the citizens can use physical stamp papers/certificates (Non-Judicial) as per guidelines/rules regulation issued by the Revenue Department from time to time in the following cases :-

- (a) Physical Stamps/certificates (NJ) purchased from Treasury, Sub Treasury, SBI and Stamp Vendor before 02.05.2016 in four Districts namely Faridabad, Gurgaon, Panchkula and Sonapat.
- (b) Physical Stamps/certificates (NJ) purchased from Treasury, Sub Treasury, SBI and Stamp Vendor before 01.03.2017 in the remaining districts.
- (c) Stamp Vendors can use physical Stamp Papers (NJ) purchased from Treasury/ Sub Treasury before 02.05.2016 in four districts namely Faridabad, Gurgaon, Panchkula and Sonapat.
- (d) Stamp Vendors can also use physical Stamp Papers (NJ) purchased from Treasury/ Sub Treasury before 01.03.2017 in the remaining districts.

3 These instructions may also be brought to the notice of all concerned in your Department for strict compliance. These instructions are also available on the official website of Finance Department (www.finhry.gov.in).






