Keeping in view of security of small denomination of non judicial stamp paper, it has been decided that Treasuries / Sub-Treasuries will issue physical non judicial stamp paper and Special Adhesive Stamps (SAS) of small denomination upto Rs. 100/- to the stamp vendors with effect from 01.05.2017. This would enable the stamp vendors to sell these papers / stamps to the general public. These instructions may be brought to the notice of the stamp vendors.
