

1. On the basis of above particulars the Monthly Financial Assistance will be admissible from **26-05-2016 to 30.06.2017** under rule 5(i) (C) of ex-gratia Scheme, 2006.
2. The family shall be eligible to receive family pension as per the normal rules only after the expiry during which he received the Financial Assistance as above.
3. The House Rent Allowance shall not be a part for the purpose of calculation of Financial Assistance.
4. The claimant shall open an account with any of the Nationalized Bank, and the payment of above Financial Assistance will be made through bank Draft or by cheque or through bank transfer every month by the concerned D.D.O.
5. **The expenditure will be met out of the Budget under the Head 2230 Labour & Employment 01 Labour-103-99-51 Setting up of Labour Welfare Center (Recurring) Monthly Financial Assistance to Smt. Chameli Devi W/o Lt. Sh. Jaipal, Peon O/o AD(IS&H) (C) Panipat.**
6. The Govt. accommodation if any allotted to the deceased Govt. employee and it has been allowed to retained for one year more to the dependent of the deceased after his death by the competent authority than license fees of Govt. accommodation will be deducted from the financial assistance.


