- Last date for registration of all departments/ SPSUs on apprentices portal www.apprenticeship.gov.in and display/update vacancies for ITI pass outs and in optional trades: - 15.03.2018.
- Last date for accepting/considering applications from candidates online through portal: - 22.03.2018.
- Selection of candidates, approval and generation of apprenticeship training contract bond of ITI pass outs and Optional Trade apprentices, on apprenticeship portal by the respective department / SPSUs :- 30.03.2018.
- Joining of candidates for apprenticeship training: latest by 10.04.2018.

It is, therefore, requested to kindly issue instructions to all Nodal Officers in your department at H.Q as well as in field offices for taking immediate necessary action for compliance.
