The Postgraduate Institute of Medical Education & Research, Chandigarh became an Institute of National Importance under an Act of Parliament. The Institute has about 5500 Group B and C employees. It provides the high quality medical treatment to the ailing patients of surrounding areas besides training of doctors. As the Institute is equipped with a large number of employees and to deal with the day to day labour problems, it is felt that suitable officer be appointed as Labour Officer.

The Institute proposes to fill up one post of Labour Officer on deputation basis in the pay scale of Rs.15600-39100 with Grade Pay of Rs.5400/- (Pre-revised) further revised in the Pay Matrix as Level 10<sup>th</sup> in the 7<sup>th</sup> CPC from Central Pool/State Pool of Labour Officers. The period of deputation shall ordinarily not exceed beyond three years.
