
Now, therefore, in exercise of the powers conferred by the second proviso of sub-section (I) of section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes **"Monday" the 28.01.2019 to be a close day (holiday)** for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana, only for their employees who are enrolled as voters in the 36-Jind Constituency of Haryana State Legislative Assembly to enable them to exercise their franchise.


