No. F.W./Election-2019/ 5614 Whereas, the General Election to Legislative Assembly of Haryana 2019 for which Repoll shall be held on the 23.10.2019 (Wednesday) as per Chief Electoral Officer, Haryana letter No. 220 Repoll/HVS Elec-2019/2AE-13941 dated 22.10.2019.

And whereas it has been considered necessary to provide opportunity to the public to exercise their Franchise.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all those adult workers working in the factories of the State of Haryana who are enrolled as the voter in the polling station mentioned in below table where re-poll to Legislative Assembly are to be held on 23.10.2019 (Wednesday) from the operations of the provision of sub-section (1) of section 52 of the said Act, for the week commencing from 20.10.2019 and ending on 26.10.2019, subject to the condition that no adult worker who is enrolled as voter in the polling station mentioned in below table shall be required or allowed to work on 23.10.2019 (Wednesday) in the factories of the State of Haryana.


