

Instructions regarding re-appropriation of fund request and submitting of bills in Treasury in month of March, 2020.

In continuation of the instructions issued vide No. 28/14/2011-5B&C dated 05th December 2012, 16th January 2013, 10th January 2014, 24th March 2015, 09th February 2016, 22nd March 2016, 22nd February 2017, 1st March 2018 and 12th February 2019. The Government has decided further to improve upon the procedure and to reduce unproductive expenditure/curb parking of funds and to avoid rush of expenditure toward fag end of financial year, as follows:-

"No bills including Works Bill, except Salary, Wages, Discretionary Grants, Petty Grants, Medical Reimbursement, GPF Advance/ Withdrawal & Centrally Sponsored Scheme will be passed by Treasury after March, 1st 2020".
