Subject: Mode of payment for Quarantine & Isolation facilities of COVID-19 suspects/ patients in Haryana.

Sir/Madam

I have been directed to invite your attention to the subject mentioned above and to state that as per the additional guidelines issued by MoHFW (GoI), the suspects/patients may be kept in quarantine/ isolation facilities i.e. COVID Care Centres (CCC), as the case may be. The COVID Care Centres are makeshift facilities. These may be set up in hostels, hotels, schools, stadiums, lodges, etc., both public and private.

CCC shall be identified and notified in each district by concerned Deputy Commissioner, strictly adhering to the guidelines and SOPs issued by MoHFW, Govt. of India vide letter dated 07.05.2020 (Annexure-A). The quarantine and isolation facilities shall be separate from each other and in any case, there shall be no intermingling of suspects and patients.

State Govt. has already fixed the rates for utilization of quarantine facilities, vide Govt. Notification No. 2020/2PM-Pkg(COVID-19)/3567-3766 dated 23.03.2020, regarding fixation of package rates of COVID-19 treatment in Private Medical Colleges and Hospitals of Haryana, which remain as such.

Further, the rates for utilization of private isolation services are being fixed as under:

1. At 3-starred Hotel: Maximum up to Rs.3000/- per day per person.
2. At 4 or above starred Hotel: Maximum up to Rs. 4000/- per day per person.

[Above rates are inclusive of charges for all basic services such as diet, laundry, housekeeping, Wi-Fi, TV, visits & monitoring by Healthcare staff, etc.]

The expenditure of private isolation facility would be borne by the patient himself, however, the Govt. isolation facilities would be available free of cost to the
