**Subject:--** Meeting of Crisis Coordination Committee held at 11:30 AM on 27th March 2020 in Main Committee Room, Haryana Civil Secretariat, Chandigarh and through VC under the Chairpersonship of Chief Secretary, Haryana-Implementation of the instructions thereof.


Kindly refer to the subject cited matter.

A Meeting of Crisis Coordination Committee was held under the Chairpersonship of Chief Secretary, Haryana through VC on 27th March, 2020 at 11:30 AM in Main Committee Room, Haryana Civil Secretariat, Chandigarh. During meeting certain decisions were taken to mitigate the present crisis due to spread of COVID-19 and following directions are hereby issued to implement the decisions:-

- 1) It shall be ensured that there should be no lay-off of workers in industries, commercial establishments etc. on account of the lockdown and coordinate with District administration for availability of passes to the account officials responsible for the pay/salary in a regulated manner like specific time and place to avoid crowding. The directions in this regard have also been issued on 23<sup>rd</sup> Mar, 2020.
- 2) Extend full cooperation to the respective Deputy Commissioners for tracking and accommodating the workers who are moving in the different areas after their industries have closed down. Such workers have to be accommodated in Public buildings like school etc. Volunteers should be roped-in to assist in providing them

with food and other essential items. The status regarding the same to be submitted in the prescribed format as provided by the District Administration.

All the Officers are directed to make compliance of these directions in letter and spirit.


