Approval of the Government for implementation of decisions taken by the Haryana Building and Other Construction Workers' Welfare Board in its 19th meeting held under the Chairmanship of Hon'ble Deputy Chief Minister on 16.01.2020.

Reference on the subject cited above.

As provided under Rule 70 of the Building & Other Construction Workers (RE&CS) Rules, 2005, approval is hereby accorded to the following decisions taken by the Haryana Building and Other Construction Workers' Welfare Board in its 19th meeting held under the Chairmanship of Hon'ble Deputy Chief Minister on 16.01.2020:-

- 1. Maternity Benefit and Paternity Benefit shall be payable upto birth of two children but shall be further extendable on the birth of third child, in case of girl only. In order to promote the girl child, Rs. 11,000/- will be paid additionally on the birth of a girl as the third child.
- 2. Benefit under the scheme "Financial Assistance for Education" shall be payable upto maximum 3 children.
- 3. The benefit under the "Bicycle Scheme" and "Toolkit Scheme" shall be provided once in five years and maximum 5 times during the working life span of a registered beneficiary.
- 4. In order to curb the fraud / bogus claims under Kanyadaan / Marriage Assistance Scheme, the dual verification system shall be adopted, under which, the elected representative and Govt. functionary will verify the claim. Sarpanch, Member of Block Samiti, Member of Zila Parishad, Municipal Councillors and Municipal Corporators shall be authorized as elected representative for certifying the claim applications for marriage assistance.
- 5. Out of total amount of Rs. 1.01 lakh of Marriage / Kanyadaan, Rs. 50,000/- shall be paid before the marriage by ensuring dual verification of the particulars of the applicant and the remaining amount of Rs. 51,000/- shall be paid on production of marriage certificate.
- 6. The officers of Employment Department, Haryana will be authorized for verifying / Certifying the requisite 90 days' work experience of the construction workers.
- 7. The amount of pension shall be uniformly kept Rs. 500/- higher than that is being provided by the Social Justice and Empowerment Department, Haryana under the

three welfare schemes i.e. old-age pension, widow pension and financial assistance for disabled children.

The present "Workers' Disability Pension" of Rs. 3000/- shall remain unchanged. In future, this pension shall only be increased to maintain the gap of Rs. 500/- with the pension paid by the Social Justice and Empowerment Department, Haryana.

8. The amount of Rs. 2,07,43,262/- will be paid to the Haryana Shehri Vikas Pradhikaran as Board's share, on account of allotted plot measuring one acre in Sector-20, Panchkula for the building of the Board's head-office.
