I am directed to address you on the subject noted above and to say that Haryana Karamchari Mahasangh with their related unions of employees of State Government, Haryana, have given a strike call on 26.11.2020. The Government has examined the issues on which the call has been given. These issues at the moment do not warrant such a course of action on their part. Therefore, the Government does not consider the call legitimate.

You are, therefore, requested to prepare a contingency plan for your department/ office/ district so that office functioning and essential services to the public do not suffer on account of the strike. Also, if any one indulges in disruption of work, such persons should be dealt with firmly.
