And whereas, it is considered necessary to provide opportunity to those who are working in the Panchkula (Haryana) and enrolled as voter in UT, Chandigarh to exercise their franchise.

Now, therefore, in exercise of the powers conferred by the second proviso of **sub-Section (I) of Section 10** of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other powers enabling him in this behalf, the Governor of Haryana hereby fixes "Friday" the 24<sup>th</sup> December, 2021 to be **Short leave (Paid)** for all Shops and Commercial Establishments situated at Panchkula falling within the jurisdiction/ area of the State of Haryana only for those employees who are enrolled as voters in the UT, Chandigarh to enable them to cast their votes.
