No. FW/Election,2021/ 4806 -Whereas the General Election of Municipal Corporation, UT, Chandigarh for which poll shall be held on the 24.12.2021 (Friday) as per letter of the State Election Commission of UT, Chandigarh, issued vide No. 6/1/MCCE/SEC/CHD/18/2021/590 dated 02.12.2021 and as per Haryana Government Notification No. 28/3/2006-3GS-II dated 10.12.2021. And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt those workers who are working in the factories situated in the District of Panchkula and are enrolled as the voters in the U.T. Chandigarh, whereby General Election of Municipal Corporation, UT, Chandigarh are to be held on the 24.12.2021 (Friday) from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 26.12.2021 and ending on 01.01.2022, subject to the condition that all the adult worker who are working in the Factories of District Panchkula and are enrolled as voter in General Election of Municipal Corporation, UT, Chandigarh -2021 shall be allowed to take a short leave on 24.12.2021 ( Friday) to cast their vote in aforesaid election.
