Kindly refer to this directorate letter no. TA/NAPS/2016/Stipend/1113-1114 dated 24.10.2017 and 1116-1119 dated 24.10.2017 on the subject cited above and vide which it has been requested to engage trade apprentices in your office and field offices @ 10% of the total manpower. In this regard, following is further intimated for information:

- The engagement of trade apprentices shall be made by all departments at their own level, among the candidates who have applied to the respective departments online on apprenticeship portal www.apprenticeship.gov.in. The advertisement has been already issued by this department in Newspapers.
- 2. The trade apprentices to be appointed in Govt. departments/ SPSUs/ Universities must be permanent resident of Haryana State and possess valid Haryana domicile certificate.
- 3. Against the total seats available for apprenticeship training, 20% SC category candidates and 27% BC (16% BCA & 11% BCB) category candidates are to be appointed. However, if the eligible candidate(s) of these categories are not available, then the vacant seats may be immediately filled up from general category candidates.
