Kindly refer to the subject cited above.

As you may be aware that Government of Haryana has recently set up Haryana Kaushal Rozgar Nigam Limited with the mandate of deploying of contractual manpower and manpower for outsourced category services in Government Departments, Boards, Corporations, Statutory Entities, State Universities and other agencies owned and controlled by the State Government. The Nigam will function under the administrative control of Skill Development and Industrial Training Department Haryana.

The Nigam is preparing the action plan for Deployment of the manpower against contractual posts and outsourced services for Departments and other State Government undertakings. For this purpose, the details of Group C and D posts and other contractual posts, outsourcing services and vacancies are urgently required as following.

1. Name of the services/posts and number of all contractual employees deployed in your organization including field offices under part-I of CS contractual policy with their job role, and name of contracting agency.
2. Name of posts and number of all contractual employees working in your organization including field offices under part-II of CS contractual policy with their job role.
3. Name of contractual posts (which are not covered in part I & II of CS outsourcing policy) and number of all contractual employees working in your organization including field offices, against these posts, and their job roles.

4. Name of part-time posts and number of all contractual employees working in your organization including field offices, against these posts, and their job roles.

It is, therefore, requested :

- (i) to issue directions to all Drawing & Disbursing Officers, (DDOs) under your Department to fill up the above details of his office in the Google link <https://bit.ly/HKRNRegistration> latest by 20.09.2021 and after filling the form take a print of the information from Google link and send a signed copy to this department through registered post or email at hkrn.gov@gmail.com.
- (ii) to appoint a Nodal Officer in the Directorate/Headquarter of your organization and send his name, designation, email and mobile number to this department for liaisoning with this department, through email hkrn.gov@gmail.com.


