Subject:- Revalidation of pending Bills presented in Finance Department / Treasuries at fag end of the Financial Year 2021-22.

Reference on the subject noted above.

It has been observed by the Finance Department that various bills as well as tokens have been submitted online through e-billing system at fag end of the Financial Year 2021-22 for making payment in the month of April, 2022. As per financial rules, the funds withdrawn from the treasury must be utilized within the same financial year. Since pending bills/tokens pertain to recurring & ongoing works expenditure and to be booked in subsequent financial years.

Therefore, it has been decided by the Government that all the pending bills which were prepared by the DDOs and these bills sent to the Finance Department at fag end of the Financial Year 2021-22 will be cleared in the 1st Quarter of 2022-23 in the current financial year. Hence, there is no need to re-prepare the same subsequently at the level of DDOs. Drawing and Disbursing Officers (DDOs) shall submit physical copy of these pending bills in concerned Treasuries. Validity of Financial sanction of these pending bills is hereby extended up to 30.06.2022.


