Naveen Kumar, Assistant Labour Commissioner, Panchkula is hereby assigned the powers to dispose of the various claim cases under the Employees Compensation Act, 1923, The payment of Wages Act, 1936 and The Minimum Wages Act, 1948 related to the jurisdiction of Assistant Labour Commissioner-I & II, Yamuna Nagar till appointment of any authority under the said Acts.

2. Smt. Nutan Kakkar, Assistant Labour Commissioner, Headquarters is hereby assigned the powers to dispose of the various claim cases under the Employees Compensation Act, 1923, The payment of Wages Act, 1936 and The Minimum Wages Act, 1948 related to the jurisdiction of Assistant Labour Commissioner-Kurukshetra till appointment of any authority under the said Acts.

The both Assistant Labour Commissioners are hereby directed to ensure that they will hold court for atleast two days in week regularly and ensure the timely disposal of all the pending claim cases under various labour enactments. Further, the weekly disposal report of the cases must also be sent to the higher authorities regularly basis.

These orders will be applicable with immediate effect and for this additional work no extra remuneration will be paid to officers.
