Admissibility of raising manpower requisitions with monthly wages above Rs. 30,000 per month

Government of Haryana has established Haryana Kaushal Rozgar Nigam Limited (HKRNL) for deploying contractual manpower for Departments, Boards, Corporations, Statutory Bodies, Universities, PSU, Mission, Authorities, etc. under the control of Haryana Government and also for private establishments.

Discussions were held at various platforms by different departments regarding provisions for enabling deployment of manpower with monthly wages above Rs. 30,000 through HKRNL portal. Policy of the Government does not restrict deployment of such manpower.

Thus indenting organizations may raise manpower requisitions as per approvals in place from Finance Department for the respective manpower. Education qualification along with experience details and admissible salaries may be provided on HKRNL portal by the indenting organizations.
