In reference to the letter no. 62/59/2021-6GS-I dated 1st November' 2021 vide which the Haryana Panchayat Sanrakshak Scheme 2021 was notified and wherein it was prescribed that Group 'A' officers in the State of Haryana shall adopt a Panchayat and perform role of a guardian /Sanrakshak overseeing implementation of various Govt schemes and also exercise better oversight on issues pertaining to welfare of residents of the Panchayat.
