No. FW/Election,2022/2126 -Whereas the General Election of Panchayati Raj Institutions in panch, ward no-3, Gram Panchayat, Marrupur, Block Radaur, District-Yamuna Nagara, Sarpanch Gram Panchayat Manota, Block Pinganawa, District, Nuh and Panches of Ward No. 1, 2, 3, 4, 5 and 6 Gram Panchayat Manota, Block Pinganawa, District, Nuh for which Re-poll shall be held on the 04.11.2022(Friday) as per letter of the State Election Commission, Haryana issued vide No. SEC/4E-II/2022/4965-4966 dated 03.11.2022.


And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories situated in the State of Haryana who are the voters in panch, ward no-3, Gram Panchayat, Marrupur, Block Radaur, District-Yamuna Nagara, Sarpanch Gram Panchayat Manota, Block Pinganawa, District, Nuh and Panches of Ward No. 1, 2, 3, 4, 5 and 6 Gram Panchayat Manota, Block Pinganawa, District, Nuh and are entitled to vote at an election to the Panchayati Raj Institutions on the day of polling from the operations of provision of sub-section (1) of section 52 of the said Act for the weeks commencing from 06.11.2022 and ending 12.11.2022, subject to the condition that no adult worker who is enrolled as the voters in panch, ward no-3, Gram Panchayat, Marrupur, Block Radaur, District-Yamuna Nagara, Sarpanch Gram Panchayat Manota, Block Pinganawa, District, Nuh and Panches of Ward No. 1, 2, 3, 4, 5 and 6 Gram Panchayat Manota, Block Pinganawa, District, Nuh be required or allowed to work on 04.11.2022(Friday) in the factories of the State of Haryana.


