Whereas the **General Election to Legislative Assembly of Himachal Pradesh-2022 is to be held on 12.11.2022 (Saturday)**, as per the letter issued by Chief Electoral Officer, Haryana vide letter No. 130 (Public Holiday)/HP Gen. Elec-2022/2AE-5136 Dated 07.11.2022.

And whereas, it is considered necessary to provide opportunity to those who are working in the state of Haryana and enrolled as voter in state of Himachal Pradesh to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes "**Saturday**" the **12.11.2022** to be the **holiday with wages** for all Shops and Commercial Establishments falling within the jurisdiction area of the State of Haryana for only those employees who are enrolled as voters in the State of Himachal Pradesh to enable them to cast their votes.






