No. F.W./Election-2022/1804 Whereas the Bye Election- to 47-Adampur Assembly Constituency 2022 for which poll shall be held on the 03.11.2022 (Thursday) as per letter of the Chief Electoral Officer, Haryana issued vide No.333(41)/Paid Holiday/Election-2022/2AE-4583 dated 11.10.2022.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt only those workers who are working in the factories in the State of Haryana and are enrolled as the voters in the 47-Adampur Assembly Constituency where Bye Election is to be held on 03.11.2022 (Thursday) from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 06.11.2022 and ending on 12.11.2022, subject to the condition that no adult worker who is enrolled as voter in 47-Adampur Assembly Constituency shall be required or allowed to work on 03.11.2022 (Thursday) in the factories of the state of Haryana.


