And whereas, it is considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes "**Sunday**" the **13<sup>th</sup> August, 2023** for the above jurisdiction to be the **holidays with wages** for all the workers/employees enrolled as voters in Gram Panchayat Ajampur, Block Naraingarh District Ambala, Gram Panchayat Chabri, Block Jind, Gram Panchayat Bhartana, Block Pillukhera, Gram Panchayat Rojkhera, Block Uchana, District Jind and Gram Panchayat Juan-1 Block Sonipat, District Sonipat working in all the shops and commercial establishments within the State of Haryana to enable them to cast their votes.
