Agency will have to score at least 60% marks in technical evaluation so as to qualify for empanelment. HBOCWW Boards' decision shall be final and binding on the participants.

3.2 Other Conditions

- 1) The selected applicant shall submit their acceptance for terms and condition and completion of work in timely manners i.e. on Rs. 100 /- stamp paper.
- 2) The Selected agency shall have to submit a Performance Bank Guarantee of 5% amount of the total work order value with a validity of minimum 02 years from the date of issuance.
- 3) If the selected applicant fails to perform as per standard, then they shall be liable for recovery as decided by the HBOCWW Board. However, liability shall be limited to the total contract cost.
- 4) The selected Applicant shall agree for on-the-spot changes suggested by the committee members and proper replacement shall be done as per the directions of the committee members.
- 5) The HBOCWW reserves right to increase/decrease the scope of this RFQ.
- 6) Applicants are advised to study all instructions, forms, requirements, and other information in the RFQ documents carefully. Submission of the RFQ shall be deemed to have been done after careful study and examination of the RFQ document with full understanding of its implications.
- 7) The response to this RFQ should be full and complete in all respects. Failure to furnish all information required by the RFQ documents or submission of a proposal not substantially responsive to this document will be at the Applicants' risk and may result in rejection of its Proposal.
- 8) If there is delay in deploying of vehicle of more than 1 week or any complaint from construction worker/employer availing the facility / verification by Authorized Regional Nodal officer of the HBOCWW board, penalty of 1% of monthly payment for every instance of delayed delivery at each respective construction site will be incurred.
- 9) If quality of the meal is found to be poor or defective in any other manner. Board shall refuse to take the supply and return the whole or part of such cooked meal supplied to the site as the occasion may arise and impose 10% penalty or may cancel the agreement forthwith.

- 10) Any major lapse in maintaining hygiene and safety standard at Mobile Play School and kitchens, quality of meals, food poisoning / health hazard due to consumption of meals, mismanagement of kids, compromise on safety of kids as deemed by HBOCWW board. In such cases, HBOCWW board may send show cause notice for forfeiture for Security Deposit, Blacklisting and Termination of contract.
- 11) If the penalty deducted is over 5% of total monthly grant payment for 3 consecutive months, HBOCWW may invoke breach and terminate the contract. The decision of the HBOCWW in this regard shall be final and binding on the successful Applicant, the HBOCWW will treat it as a case of breach of Service Level Agreement.
- 12) The successful Applicant shall be exempted from any delays on SLA parameters arising from the delay in approvals, reviews, suggestions etc. from the Board's side. Any such delays shall be notified in written by the Board.
- 13) HBOCWW will review the performance of Agency against the SLA parameters each 3 months, or at any periodicity defined in the contract document. The review / audit report will form basis of any action relating to imposing penalty or breach of contract. Any such review / audit can be scheduled or unscheduled. The results will be shared with the successful Applicant as soon as possible.
