

Deployment of Contractual Persons Policy, 2022 issued by Human Resources Department, Government of Haryana vide notification no. 16/91/2021-4HR-II dated 26th October, 2023.

Reference to the subject cited above, it is intimated to all HODs of various departments that as per amendment in Deployment of Contractual Persons Policy, 2022 dated 26th October, 2023 Clause 8.4 for engagement against a Job role under this policy, the lower age limit shall be 18 years and upper age limit shall be 42 years. However, there is relaxation of 5 years in the upper age limit in respect of reserved categories. The candidates with prior experience in Haryana Govt. Organizations can also avail the benefits of relaxation in age maximum upto 5 years by the number of years of experience (i.e. 1 year of experience means 1 year of relaxation). However the experienced candidate can avail this relaxation upto 31/03/2024 only. Further the maximum age one can be allowed to retain on deployment will be 58 years (last day of month in which the employee complete the age of 58).

Therefore, it is requested to direct all concerned to follow the amended Contractual Person's Policy in true spirits.
