Subject: Reminder for submission of feedback on completion of training program on "Mid-Career Refresher training program on Labour Laws for Labour Inspectors" from 20-24 November, 2023 conducted at HIPA, Gurugram.

This is referenced with the subject cited above.

It is to inform you that vide letter no. 33197-33222, dated 29.11.2023, all labour inspectors were directed to submit their feedback to the head office in the prescribed manner, within 2 days from the issuance of the letter.

In this regard, only 6 Labour Inspectors have submitted their replies and the reply from others is still awaited. Moreover, while going through the attendance sheet of the training program, it has come to our knowledge that 3 Labour Inspectors named Sh. Ashok Kumar (LI, Gurugram-III), Sh. Kuldeep (LI, Faridabad-I) and Sh. Satyapal (LI, Sonapat-I) remained absent from the training and did not inform the head office as well.

Therefore, as a reminder, all the 15 Labour Inspectors, pending to submit their feedback to head office are directed to do their submission on priority. Apart from this, Labour Inspectors named Sh. Ashok Kumar (LI, Gurugram-III), Sh. Kuldeep (LI, Faridabad-I) and Sh. Satyapal (LI, Sonapat-I) are ordered to submit their reasons for not informing the head office regarding their absent from the training program.

In case of finding negligence in the submission of satisfactory replies to the head office within 3 working days, disciplinary action will be taken.
