**Subject: - Clearance of outstanding committed dues in respect of State Government Department.**

On the subject cited above, you are hereby intimated that the Additional Chief Secretary to Government of Haryana, Finance & Planning Department, Chandigarh have informed that a number of Departments are not paying their dues in time in respect of energy charges, property tax, water & sewerage charges etc. to the respective Departments/Municipalities on one pretext or other vide their D.O. letter No. 28/109/2022-5B&C dated 16.11.2022. It has therefore, been decided that all the Administrative Secretaries may collect the requisite information regarding details of the duly reconciled bills in respect of energy charges, property tax, water & sewerage charges etc. which may not have been paid by 31.12.2022 on account of non-availability of funds etc. This information is to be collected from all offices of our department by 10.01.2023 positively. This would enable the Finance Department to provide additional funds, if required, at RE stage to enable the Departments to pay its committed charges within same fiscal year. In addition to this they have also mentioned that in case the aforementioned requisite information has not been furnished by Field Level Officer(s) at District level by stipulated date, a strict view may be taken against them.

Hence, in view of above you are requested to supply the requisite information regarding pending energy charges, property tax, water & sewerage charges etc., if any, have not been paid by 31.12.2022 due to non-availability of funds etc. by 10.01.2023 positively, so that consolidated information for extra budget demand in RE may be sent to the Finance Department on prescribed date positively.

It has been observed that a number of Departments are not paying their dues in time in respect of energy charges, property tax, water & sewerage charges etc. to the respective Departments / Municipalities on one pretext or other. It has therefore been decided that all the Administrative Secretaries may collect the requisite information regarding details of the duly reconciled bills in respect of energy charges, property tax, water & sewerage charges etc, which may not have been paid by 31.12.2022 on account of non-availability of funds etc. This information may be collected from all offices under your administrative control by 10.01.2023 positively and then furnish the consolidated information to the Finance Department by 31.01.2023 positively. This would enable the Finance Department to provide additional funds, if required, at RE stage to enable the Departments to pay its committed charges within same fiscal year.

I would also like to mention here that in future this exercise may be conducted in the month of November / December every year to facilitate the Finance Department to assess the actual requirement of funds on this account by the Departments. Further, in case the aforementioned requisite information has not been furnished by Field Level Officer(s) at District level by stipulated date, a strict view may be taken against them.
