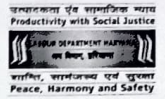

These promotions are subject to the outcome of CWP No. 7701 of 2021, titled as Naresh Kumar versus State of Haryana and others, CWP No. 3152 of 2022-titled as Saroj Bala Versus State of Haryana and others, CWP No. 25051 of 2022- titled as Sandeep Singh Versus State of Haryana, CWP No. 7903-2023-titled as Dharmavir Sharma versus State of Haryana etc. pending in the Hon'ble Punjab & Haryana High Court and Civil Appeal No. 629 of 2022 rising out of SLP (C) No. 30621 of 2011 titled as Jarnail Singh & others V/s Lachhmi Narain Gupta & others pending in the Hon'ble Supreme Court of India.
4. As per instructions no. 2/21/92-2 GS-1 dated 02.11.1992 issued by the Chief Secretary, Haryana, if a government official/Officer seeks deferment/forgoes his promotion, then his name for further promotion shall

not be considered for one year and the person promoted during this period will rank senior to him.

5. As per Haryana Civil Service (ACP) Rule-2016, if a government employee forgoes his promotion in the line of hierarchy or seek reversion on his own accord to feeder post on any ground whatsoever, such forgoing/reversion shall remain in force for a minimum period of one year or upto the period he gives in writing to re-consider his name for promotion, whichever is later. The pay of the said officials who forgoes promotion will be re-fixed as per HCS Rule-2016.
6. All officials are directed to join to their new assignments with in one week, failing which, appropriate action will be taken as per provisions in view of aforesaid points no. 4 & 5.


