Vide office order bearing Endst. No. Estt./02/2023/17218-368 dated 06.07.2023, twenty (20) officials i.e. Assistants, Statistical Assistant and Senior Scale Stenographers have been promoted to the post of Deputy Superintendents and Labour Inspectors as per provisions made in Haryana Labour Department (Group-C) Service Rule, 1982.

2. However, three officials i.e. (1) Smt. Sweety Bhardwaj, Senior Scale Stenographer, presently posted in Governor House, Haryana, (2) Sh. Narender Kumar, Assistant O/o Assistant Director, Industrial Safety & Health, Bhiwani and (3) Sh. Gaurav Munjal, (D&D) Assistant O/o Assistant Director, Industrial Safety & Health, Karnal have submitted their written requests vide letters dated 05.07.2023, 14.06.2023 and 03.04.2023 respectively that their names may not be considered for promotion to the posts of Deputy Superintendent and Labour Inspectors. Accordingly, their names have not been considered in aforesaid promotion for the post of Deputy Superintendent and Labour Inspectors in the light of instructions issued by the Chief Secretary, Haryana vide U.O. No. 2/21/92-2 GS1 dated 02.11.1992 and Rule-14 Haryana Civil Service (ACP) Rule-2016.

3. In view of the above position, rules and instructions, promotions of the following three officials have been deferred for one year, subject to condition that their names for promotion shall not be considered for one year and any person junior to them promoted during the said period will rank senior to them:-

2.	Sh. Narender Kumar, Assistant	O/o Assistant Director, Industrial Safety & Health, Bhiwani
3.	Sh. Gaurav Munjal, (D&D) Assistant	O/o Assistant Director, Industrial Safety & Health, Karnal

4. Further, as per Rule-14 of Haryana Civil Service (ACP) Rule-2016, the pay of the said officials who forgoes promotion will be re-fixed as per HCS (ACP) Rule-2016, which provides as under:-

14. Ceasing of entitlement of ACP Level.—

- (1) A Government employee who foregoes his promotion in the line of hierarchy or seeks reversion on his own accord to feeder post on any ground whatsoever, while drawing pay in—
(a) 3rd ACP Level, the pay shall be re-fixed in 2nd ACP Level;

(b) 2nd ACP Level, the pay shall be re-fixed in the 1st ACP Level;
(c) 1st ACP Level, the pay shall be re-fixed in the Functional pay structure, equal to the presumptive pay which shall have been admissible had he not been granted 3rd/2nd/1st ACP Level, as the case may be.

(2) If such Government employee becomes ready to accept promotion, in such case the period of service between the date of foregoing promotion/reversion and date of application indicating readiness to accept the promotion, subject to minimum one year, shall be excluded from the regular satisfactory service for the purpose of grant of ACP Level. On assuming the charge of promotional post the pay shall be re-fixed equal to the pay drawn in ACP Pay structure immediately before foregoing promotion or fixation of pay of the promotional post under normal rules, whichever is higher:

Provided that the request for seeking reversion or foregoing promotion once accepted by the competent authority shall not be withdrawn. Once a Government employee has foregone his promotion or sought reversion to a feeder post, such foregoing/ reversion shall remain in force for a minimum period of one year or upto the period he gives in writing to re-consider his name for promotion, whichever is later.


