OFFICE ORDER

Sh. Charanjeet Singh, Assistant was promoted to the post of Deputy Superintendent, vide this office order dated 06.07.2023, which was issued vide Endst. No. Estt./02/2023/17218-368 dated 06.07.2023, and was posted in the O/o Labour Commissioner, Haryana, Chandigarh (Headquarters). The official vide application dated 27.09.2023 has expressed his willingness to forgo his promotion and requested for reversion back to the post of Assistant due to unavoidable family circumstances and his illness.

2. The request of the official has been examined and it has been decided to revert Sh. Charanjeet Singh, Deputy Superintendent to the post of Assistant. It has also been decided that his name will not be reconsidered for promotion for at least one year and the person promoted during the period will rank senior to him, as per instructions of worthy Chief Secretary, Haryana vide U.O No. 2/21/92-2 GS1 dated 02.11.1992. Further, as per Rule-14 of Haryana Civil Service (ACP) Rule, 2016 the pay of the said official will be re-fixed as per HCS (ACP) Rule, 2016.

3. Accordingly, Sh. Charanjeet Singh, Deputy Superintendent is hereby reverted back to the post of Assistant and posted as such in the office of Deputy Labour Commissioner, Panipat against vacant post of Assistant.
