No. FW/Election/2024/ 3117 -Whereas the General Election to the Legislative Assembly of Haryana 2024, for which poll shall be held on the 01.10.2024 (Tuesday) as per letter of the Chief Electoral Officer, Haryana issued vide No. 130 (Paid Holiday) / HVS Elec-2024/2AE-7948 dated 21.08.2024.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt all the adult workers working in the factories situated in the State of Haryana who are the voters in aforesaid General Election to the Legislative Assembly of Haryana which is to be held on 01.10.2024 from the operations of provisions of section 52 (1) (a) of the said Act, for the week commencing from 29.09.2024 and ending 05.10.2024, subject to the condition that no adult worker who is enrolled as voter in aforesaid General Election to the Legislative Assembly of Haryana shall be required or allowed to work on 01.10.2024 (Tuesday) in the factories of the state of Haryana.
