- a. (i) Holding analogous posts on regular basis in the parent cadre/department,
or
(ii) With two years service in the Grade rendered after appointment thereto on regular basis in the scale of pay Rs. 6500-10500 (unrevised) or equivalent in the parent cadre/debarment; and
- b. Possessing the qualification of a bachelor degree from a recognized University or equivalent and
- c. LLB/Post Graduate Degree or diploma in Labour i.e. Labour Welfare/Personnel Management or three years experience in enforcement of Labour Laws.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications)

There should be no departmental/ vigilance inquiry pending or likely to be contemplated against the officers sponsored. The incumbent so selected would be taken on deputation initially for a period of one year which can be extended on year to year basis as per requirement of this Administration. The deputation is to be regulated as per standard term and conditions.

You are, therefore, requested to send a panel of suitable officials along-with their ACR/dossiers of last five years, No departmental/ vigilance inquiry pending certificate, integrity certificate etc within a period of one month
