Regarding treating the period of Clerks recruited against Advt. No. 05/2019, Cat. No. 01 as the 'Compulsory Waiting Period' from the date of discharge from previous/same department to the date of joining again in the same or new Department due to revise result.

Sir/Madam,

I am directed to invite your attention to the Government instructions No. 42/389/2022-5HR-II dated 16 December 2022 wherein the Government has decided that the interim period of a candidate who has been recommended against the Advt. No.5/2019, Cat. No.01 in both the merit lists of Clerks from the date of discharge from previous/same Department and to the date of joining in the same or new Department, may be treated as 'Compulsory Waiting Period' with the approval of Finance Department.

- Various Departments are seeking clarification in the matter that whether the past service should be counted for the purpose of seniority and pay protection of Clerks who has been recommended against Advt. No. 05/2019, Cat. No. 01 in both the merit list of Clerks from the date of discharge from previous/same Department and to the date of joining in the same or new Department.
- The matter has been considered by the State Government and it has been decided that past service of such Clerks who were recommended against the Advt. No. 05/2019, Cat. No. 1 in both merit lists, shall be counted for the purpose of seniority and pay protection, irrespective of the fact that they have been allotted same or different department.
- 4. It is therefore, advised that necessary action to fix the pay in all such type of cases be taken as per provision contained in Rule 10(ii) of the Haryana Civil Services (Pay) Rules, 2016 on case to case basis.
- This issues wih the concurrence of Finance Department conveyed vide U.O. No. 2/15/2018-1PR(FD)/5514 dated 11.04.2023.
- 5. These instructions may be brought to the notice of all concerned for necessary action in the matter.

- The State Government has considered the matter and decided that interim period of a candidate who has been recommended against the Advt. No. 5/2019, Cat. No. 01 in both the merit lists of Clerks from the date of discharge from previous/same Department and to the date of joining in the same or new Department may be treated as 'Compulsory Waiting Period' with the approval of Finance Department.
- It is therefore, Administrative Secretaries are advised to direct the departments under your control to examine the cases of such candidates in terms of Rule 8 (10) of Haryana Civil Services (General) Rules, 2016 and send the cases to the Finance Department mentioning the exact/actual compulsory waiting period in terms of Rule 8 (10) of Haryana Civil Services (General) Rules, 2016.

Sir/Madam,

I am directed to invite your attention on the subject noted above. It is advised to examine and accordingly sanction the compulsory waiting period at the level of Administrative Department/Head of Department/Finance Department as the case may be, in accordance with the rule 8(10) of Haryana Civil Services (General) Rules, 2016 as already advised vide Chief Secretary to Government Haryana instructions No. 42/389/2022-5HR-II, dated 16.12.2022. The rule ibid provides as under:-

#### Rule-8

- (10) "Compulsory waiting period" means the period of compulsory waiting spent by a Government employee for getting posting orders on return from foreign service, deputation, training, leave and for any other reasons for which Government employee is not accountable. This period shall be treated as duty when sanctioned by the competent authority;
  - Note 1.— Administrative Department and Head of Department are competent to sanction compulsory waiting period as duty upto forty two days and thirty days respectively;
  - Note 2.— Where compulsory waiting period exceeds six weeks, the junior-most shall be reverted to accommodate senior;
- It has been noticed that cases are being sent to the Finance Department by the Administrative Departments w.r.t. the aforementioned rule without adhering to the provision made in 'Note-1' below Rule 8 (10) of Haryana Civil Services (General)
