Subject: Regarding engagement under Outsourcing Policy Part-II.

Sir/Madam,

I am directed to invite your kind attention to Government instructions of even number dated 9th September, 2022, and dated 30th December, 2022, vide which Outsourcing Policy Part-II was revived for employees working on Outsourcing Policy Part-II against sanctioned posts and were in service as on 28.09.2021; and, they were allowed to continue till regular appointments are made against these posts or till 31.12.2023, unless they opt to be ported onto (Haryana Kaushal Rozgar Nigam Ltd.) HKRNL within a period of 3 months.

2. Now, the matter has been re-considered by the Government and extension in the engagement of employees engaged under Outsourcing Policy Part-II is given for a period of 1 year, up-to 31.12.2024, for those who did not accept the option of being ported to HKRNL, or, who are working on Group A or Group B posts, or, under any notification by the State Government.
3. It is further clarified that services of employees, who chose not to be ported to HKRNL consequent upon instructions dated 30th December, 2022, will be the first to be terminated in case regular appointment is made on such posts.
4. These instructions may please be brought to the notice of all concerned for strict compliance.
