#### **OFFICE ORDER**

Reforms circulated by "Department for Promotion of Industries & Internal Trade" (DPIIT). Government of Inda under Business Reform Action Plan (BRAP) - 2024 and aim at enhancing "Ease of Doing Business" across the country to accelerate growth of Industrial sector.

With the above background, and with reference to the **reform point no 167**, it is mandated to **publish an online dashboard in public domain.** The online Dashboard shall have following features to bring transparency in information dissemination and to help applicants to know the minimum time in which their application will be approved by the department.

- 1. Dashboard shall display the information and number of applications received, total no of application approved, average, median, minimum & maximum time taken to obtain registration /renewal and also average & application wise statutory fees paid by the applicant/ enterprise to grant approvals /certificate.
- 2. The dashboard shall be updated on real time basis or regularly (weekly/fortnightly/monthly) with the last updated date (along with time) being displayed on the portal.
- 3. The dashboard shall have functionality where the applicant can drill down and get the information on day-wise and application-wise details along with the statutory fee paid by the applicant.

For the following services

- i. License for contractors under provision of The Contracts Labour (Regulation and Abolition) Act, 1970.
- ii. Shops and Establishment Act.
- iii. Principal employer's establishment under provision of The Contracts Labour (Regulation and Abolition) Act, 1970.
- iv. Building and Other construction workers Act.
- v. Establishment under the Inter State Migrant Workmen (RE&CS) Act, 1979.
- vi. Factories Act.

The dashboard is published in prescribed format under BRAP-2024 guidelines attached hereunder as 'Annexure – I'


