Subject: General/Bye-Elections of Municipal Bodies, -- Declaration of Holiday on Poll Day.

With reference to letter No. SEC/1ME/2025/1043-1044 dated 04.02.2025 issued by State Election Commission Haryana, Panchkula on the subject cited above.

It is to informed that the date on which poll for General/Bye-Elections of Municipal Bodies, shall be held i.e. on 02.03.2025 (Sunday) and 09.03.2025 (Sunday) are closed days for all the factories as provided under section 52 of the Factories Act, 1948. Therefore, further notification to declare the said days as holiday under the Factories Act, 1948 is not required for the poll days being Sunday for conduct of general elections for the seats of Mayors and Members of all the wards of 08 Municipal Corporations and Presidents & Members of all the words of 04 Municipal Councils & 21 Municipal Committees (as per Annexure) and bye-Elections of 02 seats of Mayors i.e. Municipal Corpportations, Ambala and Sonapat, 03 seats of Presidents i.e. President, Municipal Council, Sohana (Gurugram), Municipal Committee, Assandh (Karnal) & Municipal Committee, Ismailabad (Kurukshetra) and 03 seats of Members i.e. Ward No. 11 of Municipal Committee, Ladwa (Kurukshetra); Ward No. 14 of Municipal Committee, Safidon (Jind) & Ward No. 5 of Municipal Committee, Taraori (Karnal) for which poll is going to be held on on 02.03.2025 (Sunday) and 09.03.2025 (Sunday) as mentioned in the said letter.


